Polling data repeatedly shows that healthcare affordability is the number one issue that state residents, on both sides of the political aisle, want their policymakers to work on. This checklist identifies areas where lowa is doing well and areas where it can improve.

1. CURB EXCESS HEALTHCARE PRICES:	
 Implement free, public-facing healthcare price transparency that reflects negotiated rates and features treatment- and provider-specific prices. 	×
 Create an all-payer or multi-payer claims database to analyze healthcare price inflation, price variation and utilization. 	×

2. REDUCE LOW-VALUE CARE:	
 Require validated patient-safety reporting for hospitals.¹ 	×

3. EXTEND COVERAGE TO ALL RESIDENTS:

 Provide high-quality, affordable coverage options for people whose incomes are too high to qualify for Medicaid, e.g., Basic Health Plan, reinsurance or augmented premium subsidies. 	×

4. Make Out-of-Pocket Costs Affordable:

Notes

- 1. Central line-associated bloodstream infections (CLABSI) and catheter-associated urinary tract infections (CAUTI) are two common forms of hospital-acquired infections. - 3. IA lawmakers considered, but did not pass, Medicaid work requirement legislation in 2020.
- 4. IA offers Medicaid coverage to lawfully residing immigrant children without a 5-year wait. IA does not offer coverage options for legally residing immigrant pregnant people or undocumented children/pregnant people/ adults.
- 5. IA has effective rate review as classified by CMS but does not incorporate affordability criteria into rate review.
- 6. IA has partial protections against surprise medical billing, meaning that protections only meet some of the following criteria: protections include emergency departments and hospitals, apply to all insurance types, hold consumers harmless/prevent balance billing and adopt adequate payment standard or dispute resolution process. - 7. The Federal No Surprises Act prohibits surprise medical billing in most plans effective January 2022. However, it does not cover ground ambulances which often result in surprise bills. An analysis by Johns Hopkins University conducted specially for Altarum revealed that 36% of ground ambulance rides in IA charged to commercial insurance plans had the potential for surprise medical billing.
